Approval of this application will involve consideration of the following:

1. Admission of nonresident students will only be considered when space is available.
2. The application will be reviewed in the following areas:
 - Student’s academic standing must be acceptable;
 - Student’s record must demonstrate punctual and regular attendance;
 - Your child must not have incurred serious disciplinary infractions.
3. Payment of tuition for all schools except for Northside which is zero (0), is due in advance at the beginning of each quarter. Tuition for 2018-2019 is
